The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 03/14/2021 at approximately 2154 hours, at 101-13385 Arbor Pointe Cr Tampa, FL 33617, the defendant and victim entered into a verbal argument that turned physical. The victim was laying on the bed and the defendant grabbed the victim's hand intentionally and willfully against her will. The victim attempted to fight back and as the altercation continued, the defendant pushed the victim to the ground. The defendant intentionally and willfully restrained the victim by placing his right elbow against the left side of her face. The defendant intentionally and willfully bit the the victim's left thumb while she was restrained. The victim had visible redness to her left shoulder blade, a 1 inch laceration to the back of her right arm, and a small laceration to her right thumb. The defendant and the victim have been living as a family since December 2020. The victim identified the defendant as the person who committed the offense. The defendant was positively Florida drivers license photograph.
