On August 15th, 2020, at approximately 0040 hours, I responded to 15618 83rd Way N, Palm Beach Gardens Fl 33418 for a Domestic Disturbance. Upon arrival, I met with Kimberly Genovese, who informed me that her Ex-Boyfriend, Christopher Hammel has been following her around and stalking her.

Genovese told me that she recently broke up with Hammel (On approximately 07/12/2020) and she formally told him that they are no longer together. Genovese and Hammel currently live together at the above mentioned address, but she is in the process of moving out/ selling the house. Genovese told me that Hammel has been following her around and Harassing her since she broke up with him.

Genovese informed me that she went to the Starbucks, 5500 Military tr, Jupiter Fl, at approximately 1200 hours, (08/14/2020) for a work related event. Once she was there for a few moments, she noticed Hammel's vehicle in the parking lot. She then saw the window roll down and she could see Hammel sitting inside of his vehicle. She left the location and continued on with her day. At approximately 2032 hours, Genovese drove to 2500 Ocean Dr, Vero Beach, Fl 32963, which is about one hour and fifteen minutes from her house. Once she arrived, she noticed that Hammel had followed her there and confronted her and started knocking on her window. Genovese called Vero Beach PD (Incident #81420-121) and spoke to them about how Hammel had followed her all the way up to this location. Genevese then drove back to her residence, where Hammel started yelling at her. Genovese separated herself from Hammel and then she called PBSO. Hammel left the residence shortly after and told her that he was going to stay at someone else's house for the night.

Genovese showed me her call records for the last two days and he had called her at least thirty-three times. Genovese told me that he calls her from blocked numbers and other phone numbers as well, so I was unable to get an exact number of times Hammel called her. Genovese then showed me her text messages and in the last twenty-four hours, he texted her at least forty times. Genovese told me that she was fearful of him and she was did not not know what else to do.





On August 17th, 2020 at approximately 1322 hours, Genovese sent me an email which she stated "He grabbed me last night I did push him to get him away from me. I keep asking him to leave me alone. He will not ". The email had a video attached which appear to show Genevese and Hammel in a verbal argument. Hammel then takes his right hand and grabs Genevese's left butt cheek area. Genevese has an immediate astonished reaction and quickly pushes Hammel away from him in a defensive manner.

On August 17th, 2020, at approximately 2300 hours, I made contact with Genevese, where she explained to me that the incident occurred at 2109 hours, from the previous day (08/16/2020). Genevese told me that after Hammel grabbed her, she felt disgusted and scared. Genevese said that she is in fear for her life and that she thinks the physical abuse will continue and possibly get worse.

I then made contact with Hamel and based on the above mentioned investigation, Christopher Hammel was arrested and placed into handcuffs, which were double locked and checked for tightness. Hammel was charged with Simple Battery (Domestic), FSS 84.03(1)(a)(1) and Stalking, FSS 784.048(2). Hammel was subsequently transported to County Jail.
