The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:

The defendant was stopped by Cpl Price after he stopped in roadway and then sped off speeding down Kennedy Blvd at 59 MPH in a 40 MPH zone, while driving a MERZ 4 Door SUV 4-door (FL Tag #L5ETP). CPL Price observed the DEF. to have glassy eyes and odor of alcohol on his breath and called for a DUI investigator. I arrived on scene, and during observations, the defendant displayed multiple clues of impairment to include, glassy eyes, repeated himself, slurred/mumbled speech, and fumbling with his phone trying to call his lawyer and wife, and the distinct odor of alcohol emanating from his breath.

The DEF. refused to participate in FSE's and based on totality of circumstances and evidence, the defendant and was arrested for DUI.

While at Central Breath Test, the defendant refused to provided a breath sample after being read implied consent at HCSO video room #1.

The defendant was identified via his FL driver's license.
