PERSONAL CONTACT

DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

Upon my arrival, Ofc. Eriksson advised she was traveling westbound on PGA Boulevard at Lake Victoria Gardens Avenue when she saw a red Ford Explorer bearing New York Tag HYP4277 traveling westbound without rear lights activated. Ofc. Eriksson followed the Explorer with it stopping at the red light at PGA Boulevard and Interstate 95. Upon receiving a green light, the vehicle stayed stopped for approximately 2 to 3 seconds before the driver realized it was green and continued westbound. Ofc. Eriksson observed the Explorer swerve within the lane and drive over the left fog line and reflectors separating the left through lane and the left turn lanes to N Military Trail. The Explorer stopped in the through lane for the red light at N Military Trail. When the light changed from red to green, the Explorer again stayed stopped on the green for approximately 10-15 seconds where Ofc. Eriksson had to use her airhorn to get the driver's attention. The Explorer took off at a high rate of speed and Ofc. Eriksson had to catch up to the Explorer and paced it with a steady speed of 67mph in a 45mph zone as it was serving in its lane. Officer Eriksson initiated the traffic stop and the vehicle came to final rest just west of the Florida's Turnpike on PGA Boulevard (in front of Mirasol Walk - 6249 PGA Boulevard.) and Ofc. Eriksson identified the white male driver and the sole occupant of the Explorer via his New Jersey driver's license as Christopher Estevez.

OBSERVATION OF DRIVER:

Upon approach to the Explorer, I noticed the Explorer was in good condition. While speaking with Estevez from the driver side window I detected the odor of unknown alcoholic beverage emanating from his breath. Estevez's was wearing a salmon colored long sleeve dress shirt, blue jeans and brown shoes, which was neat in appearance. Estevez had a slight accent, his speech was quiet and at times slurred. I observed Estevez's eyes to be glassy, watery and bloodshot. Estevez exited the vehicle and did not leave enough space between him and the door, causing the door to hit him as he was closing it.

DRIVER'S STATEMENTS:

Estevez stated he was driving with his lights off and stated he should have known; as well admitted to "driving over 45mph." Estevez stated he was going to PGA National to his rental. Estevez stated he had one (1) Scotch with ice at The Woods restaurant in Jupiter with dinner. Estevez stated he ate steak and broccoli. Estevez agreed to perform the Standardized Field Sobriety Tasks (SFST's).

ODORS:

Odor of unknown alcoholic beverage.

GENERAL OBSERVATIONS

SPEECH: Estevez had a slight accent, his speech was quiet and at times slurred.

ATTITUDE: Calm, Cooperative, Respectful, Mood-swings to Demanding, Uncooperative, Tense

CLOTHING: salmon colored long sleeve dress shirt, blue jeans and brown shoes, which was neat in appearance

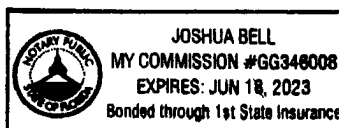

Other Observations:

Vertical gaze nystagmus was found. I also observed Estevez's eyes to be bloodshot, watery and glassy. Estevez had a visible sway. Estevez was unable to stay focused on the stimulus and anticipated the movement. Estevez was unable to keep from moving his head during the task. I had Estevez support his head with his hands, locking his elbows into his chest to keep from moving his head.

WALK & TURN:

The instructions were explained and demonstrated to Estevez. During the instructional phase, Estevez was unable to keep balance, swaying and stepped out of position. After instructions and Estevez stating he understood, Estevez started on command. Estevez missed heel-to-toe on step 8. Estevez walked off the line on steps 2, 4 and 6. Estevez did not turn as instructed and demonstrated. On the return, Estevez missed heel-to-toe on step 9. During the task, Estevez stopped. Estevez raised his arms more than six inches during the task.

ONE LEG STAND:

The instructions were explained and demonstrated to Estevez, who stated he understood. Upon the command to begin, Estevez swayed while balancing. Estevez raised his arms more than six inches to maintain balance. Estevez put his foot down on 1000-3. During this task, I also observed Estevez look forward not at his feet as instructed. Estevez did not count as instructed, restarting the counting after reaching 1000-10. Estevez did not keep his legs straight as instructed. Estevez did not keep his foot elevated as instructed. Estevez visibly swayed during the task.

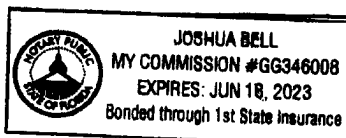

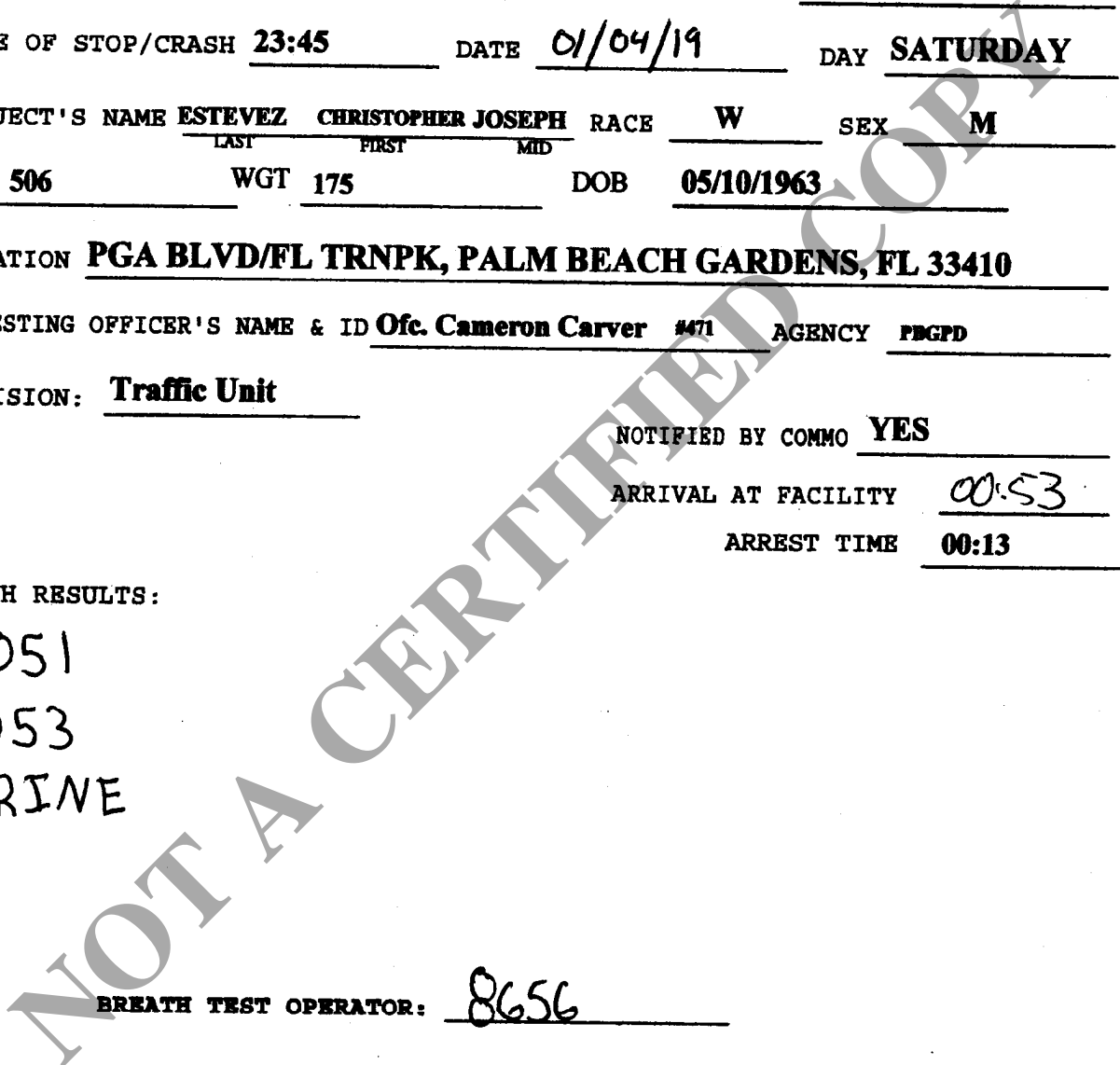
