


I was working for the Palm Beach County Sheriff's Office Road Patrol Division driving a unmarked Sheriff's Office vehicle and wearing a full Sheriff's Uniform and full duty belt.

I observed a green truck turning east onto Okeechobee Blvd from West Drive at a high rate of speed causing the wheels to slide. I was able to catch up to the same vehicle at Okeechobee Blvd and Haverhill Road, West Palm Beach Florida.

I observed the defendant's eyes to be glassy and blood shot. I also observed the defendant to have a slow and slurred speech. The defendant was asked to step in front of my patrol car, as he stepped off of his car he staggered to the side and had an unstable balance. I also observed the defendant to have a sway as he stood normally without walking.

DRIVER'S STATEMENTS:

The defendant stated he was on his way home from the Blue Boar from having drinks. He stated he has an issue with his right eye peripheral vision. He also stated he believes he has a benign tumor in his right knee, however, it does not affect his walking typically. He stated he is a generator installer and last worked today. He stated he is not taking any medications. He stated it was around 130 or 2AM, it was actually 403AM. He stated he was traveling northbound on Haverhill Rd. He stated he has not taken any drugs or marijuana today. He stated he had 3 Bud Light beers, and 2 Crown Royal shots. He stated he does not recall when he had his first drink, he also stated he had his last drink about 10 minutes prior to being pulled over.

ODORS:

An obvious odor of an unknown alcoholic beverage coming from his breath which intensified as he spoke with me.

Other Observations:

The defendant was placed into the instructional stance for the Horizontal Gaze Nystagmus. He verbally identified the blue stimulus that I was holding up. He was told to follow the stimulus with his eyes only and not move his head. I checked his eyes for equal pupil size, equal tracking, and resting nystagmus. He was reminded several times not to move his head. I did not observe any vertical nystagmus in either eye. He swayed from side to side.

WALK & TURN:

I explained and demonstrated the instructions for the "Walk & Turn" to him. He stated he understood the instructions and had no questions for me. He failed to maintain the instructional stance by separating his feet to help steady himself. He stepped off the line several times. He did not walk heel to toe as instructed. He did not count as instructed. He took the incorrect number of steps. He improperly turned around. He used his arms for balance.

ONE LEG STAND:

I explained and demonstrated the instructions for the "One Leg Stand" to him. He stated he understood the instructions and had no questions for me. He failed to maintain the instructional stance by separating his feet to help steady himself. He swayed from side to side. He raised his right leg. He did not count as instructed. He used his arms for balance by raising them more than 6 inches from his body. He put his foot down prior to the 30 seconds elapsing.

FINGER TO NOSE:

I explained and demonstrated the instructions for the "Finger to Nose" task to him. He stated he understood the instructions and had no questions for me. He failed to maintain the instructional stance by separating his feet to help steady himself. He swayed from side to side. He did not use the tip of his finger on each attempt as instructed, instead he used the pad of his finger. He did not touch the tip of his nose on each attempt as instructed. He also searched for the tip of his nose. He did not keep his eyes closed the entire time as instructed.

ROMBERG ALPHABET:

I explained and demonstrated the instructions for the "Rhombert Alphabet" task to him. He stated he understood the instructions and had no questions for me. He failed to maintain the instructional stance by separating his feet to help steady himself. He swayed from side to side. He incorrectly recited the English Alphabet. He did not keep his eyes closed the entire time as instructed.
