The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:
 On the above listed date, time, and location I observed a grey Honda Civic bearing FL tag #ETMC16 (Vin: JHMF84F20CS007591) traveling westbound on Bloomingdale Av. This vehicle failed to dim high beams for a vehicle traveling in front of me. I activated my emergency equipment to conducted a traffic stop at the above listed location. I made contact with the defendant and observed signs of impairment to include bloodshot watery eyes, slurred speech, and the odor of an alcoholic beverage emitting from his breath. Post Miranda, the defendant advised he did not understand his rights. The defendant refused the opportunity to perform Standardized Field Sobriety Exercises after being advised that Standardize Field Sobriety Exercises are voluntary and that the exercises confirm or dispel any suspicion of impairment. However, if he refused to perform the following exercises, he could be arrested for suspicion of DUI based on the totality of the circumstances, and that his refusal to perform the requested exercises will be used against him in a court of law. The driver acknowledged the warning and he was arrested for DUI based on the totality of the circumstances. The defendant refused to provide a lawful breath sample after Implied Consent warning was read. I conducted a DAVID query of the defendant, which revealed a prior refusal to submit to breath/urine/blood (02/24/2013, Citation/Case #: 5967XGA). The defendant was identified by his DAVID photo.
