The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:  
 On 02/22/2020, at approximately 0000 hours, the defendant and victim were engaged in a verbal argument in their shared residence at 10413 Avian Forrest Dr. The victim and defendant are in an intimate relationship, and have been married for approximately five months. During the argument, the victim was grabbed from behind by the defendant without permission, and thrown to the ground against her will. The victim struck the right side of her head on the ground, causing bruising and swelling to the right side of the victim's forehead.

The victim identified the defendant as her husband, Christopher Medaugh. Christopher Medaugh was positively identified via the photograph on his New Mexico driver's license. Due to the nature of Medaugh's offense, he does not qualify for the APAD program.
