





On the 8 day of May , 2021 at 23:11 (Specifically include facts constituting cause for arrest.)							
On Sunday May 9, 2021 at approximately 2311 hours, I responded to Buccan restaurant, 350-101 South County Road, Palm Beach in reference to a disturbance in progress. The details are as follows: At approximately 2243 hours, Palm Beach communications dispatched a call of a disturbance in progress, detailing that a subject wearing a blue and white polo shirt had fled Buccan restaurant running westbound on Australian Avenue being chased by restaurant staff. I arrived on scene at Australian Avenue and observed a subject matching the description running on the roadway surrounded by restaurant staff. I made contact with the restaurant staff, whom all stated that the subject on scene had willfully destroyed restaurant property and had acted in a way to cause a public disturbance to numerous restaurant patrons. I made contact with the suspect who identified himself via Connecticut Driver's License as Christopher John O'Reilly (W/M DOB: 04/19/1989). O'Reilly stated he had fled the restaurant after management demanded he pay his bill, and made other belligerent nonsensical statements. O'Reilly was detained on scene and read his Miranda Warnings to which he replied to have understood. I made contact with Buccan general manager Andrew Boles (W/M DOB: 09/21/1977) who stated that he witnessed O'Reilly damage a restaurant chair after he slammed it onto the ground. Boles approached O'Reilly and asked him to leave the scene. O'Reilly then knocked over the valet stand in front of the restaurant. Boles further stated that O'Reilly then threw a trash receptacle into the roadway and damaged a planter which belonged to the restaurant. Boles stated that the damage to the planter resulted in 400 USD of damage and that the damage to the chair resulted in 100 USD of damage, with a total of 500 USD of property damage to Buccan restaurant. Boles also stated that O'Reilly had not paid for the food and drink services provided to him by Buccan. Boles provided a receipt of services provided to O'Reilly which totaled 72.76 USD. Boles stated that he wished to prosecute.

<p>I made contact with Facundo G Paredes (W/M DOB: 05/17/1980) an employee of Mpire Valet. Paredes stated that he witnessed O'Reilly throw a restaurant chair, and then witnessed O'Reilly push the valet stand on to the floor damaging it. Paredes then witnessed Oreilly throw a garbage receptacle and push a restaurant planter onto the floor damaging it. Estimated cost of damage to the valet stand was 100 USD. Paredes contacted the owner of Mpire Valet who stated that O'Reilly had caused property damage to the valet stand and that he wished to prosecute.</p> <p>Based on the above facts, O'Reilly had willfully damaged Buccan and Mpire Valet property in excess of 200 USD less than 1000 USD, had been intoxicated in a public space and caused a public disturbance, and had defrauded Buccan restaurant of the food and services provided in total of 72.76 USD. Therefore Probable Cause existed to arrest Christopher John Oreilly for Criminal Mischief as pursuant to F.S.S. 806.13(1)(b)(2), Disorderly Intoxication as pursuant to F.S.S. 856.011, and Defraud an Inn Keeper as pursuant to F.S.S. 509.151.</p>
