The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:

The defendant was driving a black 2021 Toyota Corolla (FL TAG #JBLN22) out of a parking lot in Ybor City, when he drove over raised train tracks, then backed out of the lot and directly towards a police vehicle, almost striking it. During the traffic stop for the infraction and suspicious driving patterns, the defendant was identified via a FL DL and exhibited several clues of impairment, to include: watery/bloodshot eyes, blank/dazed stare, slurred speech, appeared tired/lethargic, was uncoordinated, admitted to drinking "several vodka drinks" prior to driving, and emitted a distinct odor of an alcoholic beverage from his breath. He was arrested for DUI following a poor performance on SFSEs. While at CBT, he was read Implied Consent, and provided 2 valid breath samples, measuring .107/.122 BrAC.
