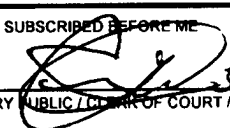

At approximately 20:21 hours on 04/02/2022 Officer Yochum and I were conducting speed enforcement on S.R. 811 (S Alternate A1A) in the 2100 block in the Town of Jupiter, Palm Beach County, FL. We were monitoring both directions of travel while stationary facing south in the median break across from Three Palms Plaza (2141 S Alternate A1A). Officer Yochum advised me of a speed violation on a vehicle traveling southbound in the inside lane of S.R. 811. The vehicle was exceeding the posted speed limit of 50 MPH. I turned my headlights on and began catching up to the vehicle. The driver did not realize I had turned my headlights on and began following them. While I began catching up to the vehicle Officer Yochum advised the vehicle continue to travel between 57 MPH and 65 MPH. The driver and later found to be the offender, Christopher S Spero; W/M; 12/17/1981, hit the vehicle breaks multiples times when there were no traffic in front of him or traffic control devices indicating to stop. I finally caught up with the Gray Honda bearing Massachusetts Tag 8MK761. I called out a traffic stop to dispatch and was waiting for them to advise the tag and vehicle. While waiting for dispatch, the vehicle made an unusual wide left turn onto S Donald Ross Road, going out of its designated lane. I then turned on my patrol vehicle's lights and siren. The final stop of the traffic stop was the eastbound lane of Donald Ross Road. I then approached the driver's side window, I introduced myself and immediately smelled an odor of an unknown alcoholic beverage coming from the vehicle. I asked Spero for his driver's license, insurance, and registration. When Spero was speaking he slurred his words and began to think longer than usual before answering my questions. I advised Spero to exit his vehicle so I could speak to him in-depth. I asked Spero where he was coming from and he stated he was coming from The Loxahatchee Club. At this time I could smell the odor of an unknown alcoholic beverage coming from Spero's breath. I asked him if he had been drinking tonight and he stated he had, he advised he had a couple of glasses of wine. I asked Spero to consent to Standardized Field Sobriety Tasks so I know

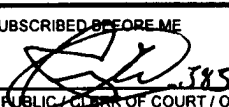

he could safely drive tonight. He asked what if he could not complete them due to a medical problem to which Officer Yochum asked what medical problems does he have, he did not answer and changed the subject. Spero then asked me what would happen if he refused to do the Standardized Field Sobriety Tasks, I advised him of his Taylor Warnings. Spero stated he understood his Taylor Warnings and refused to do the Standardized Field Sobriety Tasks. In conclusion to my investigation, I had probable cause to place Spero under arrest for DUI. I placed handcuffs on Spero and double-locked them. I then placed Spero in the back right seat of my patrol vehicle. After placing Spero under arrest, I requested at roadside that he provide a lawful sample of his breath for the purpose of determining the alcohol content. Spero refused. I advised Spero of Implied Consent, Officer Yochum confirmed he understood. Spero immediately refused a second time at 20:39 hours.
