The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On the listed date, time, and location, I responded in reference to a traffic crash involving two vehicles. The defendant was identified as the driver of the at fault vehicle by the listed victim. During my crash investigation I observed several signs of impairment of the defendant. Those observations included watery bloodshot eyes, the odor of alcohol emanating from his breath, slurred speech, and fumbling with documents. Upon completion of my crash investigation, he was advised of his Miranda rights, which he invoked and did not wish to speak with me. I then requested him to perform a series of standardized field sobriety exercises and he refused. I then requested him to submit to a lawful test of his breath and he refused. I advised him of the refusal portion of implied consent and he still refused. The defendant was transported to the Orient road jail for booking. All of the above occurred in Hillsborough County, Florida.
