The undersigned swears that he/she has reasonable grounds to believe that the above named defendant on the 14 day of DECEMBER, 2019,

at approximately 1:37 AM, at 200 STARCREST DRIVE ; APT 204, in Pinellas County did:

ACTUALLY AND INTENTIONALLY TOUCH OR STRIKE IZABELA BORCZYK, HIS GIRLFRIEND AND CO-HABITANT, AGAINST HER WILL.

THE DEFENDANT AND THE VICTIM HAVE BEEN DATING FOR APPROXIMATELY THREE (3) YEARS. THEY HAVE BEEN RESIDING TOGETHER AS CO-HABITANTS FOR AROUND ONE (1) YEAR.

EARLIER IN THE EVENING, THE PAIR WENT TO A HOLIDAY PARTY, WHERE THE DEFENDANT WAS CONSUMING ALCOHOLIC BEVERAGES. THEY RETURNED TOGETHER TO THE OCCURRED, WHERE A VERBAL ALTERCATION BECAME PHYSICAL IN NATURE.

DURING THE ALTERCATION, THE DEFENDANT "PUSHED" THE VICTIM TO THE GROUND. AS A RESULT OF THE INTENTIONAL AND WILLFUL SHOVE, THE VICTIM FELL TOWARDS THE GROUND, WHICH RESULTED IN THE VICTIM SMASHING THE SIDE OF HER FACE AGAINST THE CORNER OF A SMALL TABLE.

THE VICTIM SUSTAINED NOTICEABLE INJURIES, WHICH INCLUDED HEAVY BRUISING, BLEEDING AROUND HER NOSE/FACE AREA, AND PRONOUNCED "LUMPS" ON HER HEAD CONSISTENT WITH BEING BATTERED. THE VICTIM MADE SUBTLE STATEMENTS CLAIMING THAT THE DEFENDANT HAS BEEN PHYSICAL WITH HER IN THE PAST, BUT SHE WAS RELUCTANT TO PROVIDE ANY CLARIFYING INFORMATION TO LAW ENFORCEMENT. UPON LEARNING THE DEF WAS IN CUSTODY THE VICTIM STATED, "YOU'VE KILLED ME, HE IS GOING TO KILL ME". THE VICTIM WAS HAVING A HARD TIME ANSWERING QUESTIONS AND ONE OF HER PUPILS WAS NOTICEABLY LARGER THAN THE OTHER. HOWEVER, SHE REFUSED FD ASSISTANCE AND SIGNED FD'S REFUSAL FORM.

POST MIRANDA THE DEF STATED HE DOES HAVE AN ANGER ISSUE BUT HE DOES NOT WANT TO ADMIT TO ANYTHING WHICH WOULD INCRIMINATE HIM AND HE REFUSED TO COOPERATE.

THE DEFENDANT CAME BACK CLEAR AND DID NOT SHOW ANY PREVIOUS BATTERY CONVICTIONS WHEN A CRIMINAL HISTORY REPORT WAS RAN.
