The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did
 Cierra Rabine was observed asleep at the wheel of a blue Nissan Rogue Sport bearing (MD 6EN3656) on E Columbus Dr at I4. Her foot was on the brake pedal, the car was in gear, and the engine was running. The vehicle rolled forward into the front bumper of a patrol vehicle that was used to box in it to prevent it from going into the intersection. During observations, she displayed indicators of impairment to include having red glassy eyes, being dazed and confused, and the distinct odor of an alcoholic beverage on her breath. She advised she was tired and just heading home to Brandon from her mom's house in Riverview. She displayed additional indicators of impairment during SFST's and was arrested for DUI. She was taken to CBT where she took the breath test. She provided breath samples of .116/.114. Rabine's identity was verified using her state of Florida driver's license.
