The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did

The defendant was observed driving westbound on Kennedy Bv W near Lois Av at a high rate of speed. The vehicle was paced at 60 mph in a 45 mph zone. While pacing the vehicle, I observed it to weave to its right with passenger tires riding the lane divider. I activated my emergency lights at Kennedy Bv W / Westshore Bv in an attempt to conduct a traffic stop. The vehicle continued westbound, weaving in its lane, for approximately .2 miles, passing several parking lots and other areas to safely stop before abruptly stopping halfway in the lane of travel on Memorial Hw north of Kennedy Bv. Upon contact with the defendant, I detected the odor of an alcoholic beverage emanating from her breath. Her eyes were glassy and her speech was slurred. The defendant exited her vehicle and appeared unsteady on her feet. The defendant refused to participate in SFSE's and was arrested for DUI.

The defendant refused to provide a breath sample after being read Implied Consent.

The defendant was ID'ed via FL DL.
