On July 11, 2020, I Trooper Dominic Alexandre of the Florida Highway Patrol was parked in my marked FHP patrol vehicle, Tag Number: 0971, on the left paved shoulder on Interstate 95 (State Road 9) north of Atlantic Ave (State Road 806) on 6:03 PM. A white in color Ford 250 pickup truck pulled up in front of me. The driver of the Ford F250, who was identified as Edward Stanley Jones, Florida Driver's License Number: J-520-237-60-300-0, advised me that white in color SUV bearing the Florida tag: JDNG70 collided with his pickup truck. Mr. Jones stated that he was traveling in the center lane and the white in color SUV sideswiped his vehicle and the vehicle continued traveling northbound. An independent witness who was identified as Scott Matthew Pritchard, Florida Driver's License Number: P-632-793-65-343-0 pulled over behind my patrol vehicle and stated that he witnessed the crash happened and could attest to what Mr. Jones was saying.

While in my patrol vehicle finishing paperwork for the hit and run crash, Lake Worth Regional Communication Center (LWRCC) dispatched a BOLO of a white SUV traveling varying rates of speed and almost collided with the concrete traffic barrier in the median. SGT Alarcon was able to intercept the vehicle and the vehicle came to a complete stop on the northbound Interstate 95 (State Road 9) exit ramp to Palm Beach Lakes BLVD. SGT Alarcon was able to confirm the vehicle was a white in color Honda CRV bearing a Florida tag: JDNG70. I

confirmed with dispatch via radio that he had stopped my suspect vehicle and I shortly arrived at his scene at 6:54 PM.

When I arrived at the scene, SGT Alarcon briefed me on his traffic stop. SGT Alarcon would supplement this report on a later date. When I inspected the white in color Honda CRV SUV, I was able to confirm that the Florida tag: JDNG70 and that there was damage on the front right bumper that was consistent with Mr. Jones's and Mr. Pritchard's accounts of the crash that occurred earlier. When I approached the driver, who was identified as Claudia Gabriela Hernandez Irias by her Florida Driver's License: H-655-107-91-645-0, I could smell a strong odor of alcohol emitting from her facial area. She had bloodshot watery eyes, was swaying side to side, and had a slurred speech when she talked. I had Ms. Irias come to front of my patrol vehicle and I asked her questions relating to the motor vehicle crash she was involved in earlier. Ms. Irias repeated that she has car insurance, she could take care of her car, and that she is a paralegal. As I continued to have a conversation with her she started to raise her tone of voice and continued reiterate that she is a paralegal. At that point, I advised Ms. Irias that I was done with my crash investigation and I was conducting a DUI investigation. I advised Ms. Irias if she was willing to participate in Voluntary Field Sobriety Tasks at 6:57 PM. Ms. Irias stated that she did not have to answer to my request. She was asked several times to participate in the Voluntary Field Sobriety Tasks but she refused. I then advised Ms. Irias that by refusing the Field Sobriety Tasks that I would have to determine if she was impaired by my physical observations and Ms. Irias still refused to conduct the voluntary Field Sobriety Tasks. Therefore based on my observations, my training and experience and the totality of the circumstances, she was placed under arrest for DUI at 6:59 PM.

I transported Ms. Irias to the BAT at the Palm Beach County Jail where she was observed by me for a period of 20 minute period starting at 7:57 PM where she did not regurgitate and did not put anything in her mouth Ms. Irias was asked if she would provide a breath sample, to which she did not consent. I read Ms. Irias the implied consent warning, which she understood. After reading the implied consent warning, Ms. Irias agreed to provide a breath sample. The first breath sample was 0.155 and the second breath sample was taken as a Refusal. Ms. Irias continued to blow an inadequate amount of air on the second breath sample and she would not blow again. The time of the refusal was 8:32 PM. Ms. Irias was
