The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:

On 04/20/2020, at approximately 0248 hours, Deputy Spanier responded to 3130 Sligh Av W in reference to a suspicious vehicle. Deputy Spanier observed a 2016 black Jaguar F-Type bearing FI tag LPTV39 (VIN:SAJWJ6FV6G8K26764) parked on the side walk outside the apartment complex with music playing at a high volume. Deputy Spanier observed the defendant slumped over and asleep in the driver seat with the ignition running and a White Claw between his legs. Deputy Spanier was able to wake the defendant and when he did, he noticed several indicators of impairment. Affiant responded to the scene, detected signs of impairment, and requested the defendant perform field sobriety exercises which the defendant agreed to perform. During the exercises, the defendant showed signs of impairment and was subsequently arrested. Post Implied Consent, the defendant provided a lawful breath sample that resulted in a BAC of .208/.203. The defendant was positively identified via FL DL.
