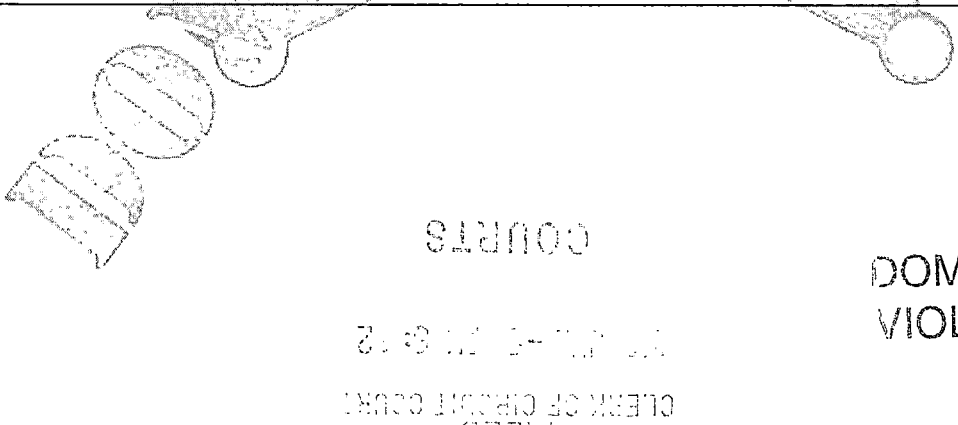
The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did
