UNLAWFULLY AND WITHOUT INVITATION OR LICENSE DID ENTER OR REMAIN IN THAT CERTAIN STRUCTURE, TO-WIT: DEFENDANT REACHED INTO THE OPEN PASSENGER SIDE DOOR OF THE VEHICLE AND PUNCHED VICTIM IN THE FACE. THE DEFENDENT SPONTANIOUSLY STATED HE PUNCHED THE VICTIM AFTER THE VICTIM PUNCHED HIM. HOWEVER, THE WITNESSES STATED AND VIDEO SHOWED THE DEFNDENT REACH INTO THE VEHICLE THE VICTIM WAS SITTING IN AND PUNCH THE VICTIM FIRST. POST MIRANDA THE DEFNDENT CONTINUED TO STATED HE WAS PUNCHED FIRST BY THE VICTIM.

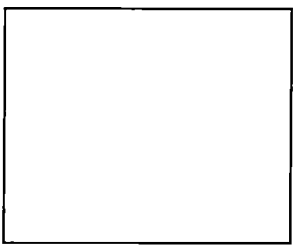

THE VICTIM AND TWO OTHER OCCUPANTS GOT OUT OF THE VEHICLE TO CONFRONT THE DEFENDENT AND A MINOR PHYSICAL ALTERCATION ENSUED. DURING THE PHYSICAL ALTERCATION THE DEFENDENT DREW HIS M&P 9 SHIELD 9MM HANDGUN AND POINTED IT AT THE VICTIM AND THE TWO OTHER INDIVIDUALS INVOLVED IN THE PHYSICAL ALTERCATION. 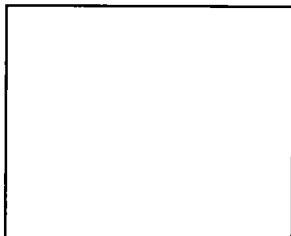

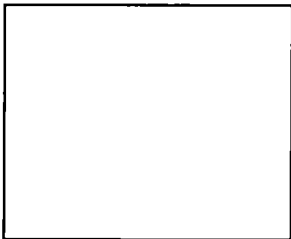

DID THEN AND THERE INTENTIONALLY AND UNLAWFULLY THREATEN TO DO VIOLENCE TO CONNOR SHAUN NEFF WHILE HAVING THE APPARENT ABILITY TO CARRY OUT SAID THREAT AND DID CREATE A WELL FOUNDED FEAR IN CONNOR SHAUN NEFF THAT SUCH VIOLENCE WAS IMMINENT AND IN THE COMMISSION OF SAID ASSAULT DID USE A DEADLY WEAPON, TO-WIT: A M&P 9 SHIELD 9MM, A BETTER DESCRIPTION OF WHICH TO THE STATE ATTORNEY IS UNKNOWN, BY POINTING THE FIREARM AT CONNOR SHAUN NEFF. THE DEFENDANT AT THE TIME OF THE ASSAULT NOT HAVING THE INTENT TO KILL CONNOR SHAUN NEFF.

THE DEFENDENT APPROACHED THE VEHICLE THE VICTIM WAS SITTING IN AFTER THE VICTIM'S BROTHER (LIAM STANLEY NEFF) CALLED THE DEFENDENT A "DENIM CHICKEN". THE VICTIM GOT OUT OF THE VEHICLE TO SEPERATE LIAM STANLEY NEFF AND THE DEFENDENT AND A MINOR PHYSICAL ALTERCATION ENSUED. DURING THE PHYSICAL ALTERCATION THE DEFENDENT DREW HIS M&P 9 SHIELD 9MM HANDGUN AND POINTED IT AT THE VICTIM AND THE TWO OTHER INDIVIDUALS INVOLVED IN THE PHYSICAL ALTERCATION. 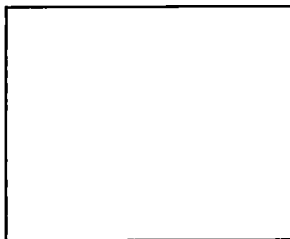
