

On the **13** day of **January**, **2020** at **14:31** (Specifically include facts constituting cause for arrest.)

The following was captured on Jupiter Police BWC and is a summary of the video footage.

On 1/13/2020 at approximately 1145hrs I was dispatched to a careless driver call in the area of S US Highway 1/Marcinski Rd, Jupiter, Palm Beach County, Florida. While enroute Northcom advised that a white pickup truck pulling a boat and trailer was all over the roadway and had come to a stop at S US Highway 1 and Marcinski Rd. Northcom advised that the caller was still following the truck and ran the red light going east onto Marcinski Rd approaching S A1A. At this point, Ofc. C Irons observed the vehicle while she was on another call. Ofc. Irons explained the vehicle went north on S A1A from Marcinski Rd and she began to follow trying to catch up to the vehicle. Ofc. Irons advised the vehicle was all over the roadway and attempted to conduct a traffic stop on the vehicle by activating her red and blue lights and sirens. Ofc. Irons stated that the vehicle was failing to yield and continued north bound on S A1A. Ofc. Irons later advised the vehicle came to a stop north on Xanadu Place on A1A. At this point the driver exited the vehicle and Ofc. Irons requested emergency traffic. Based on this circumstance I responded to the scene "code 3" utilizing my red and blue emergency lights and sirens. As I was approaching the scene Ofc. Irons explained that she had the male driver in protective custody.

Upon arrival to the scene I spoke to Ofc. Irons and she explained the driving pattern of the white truck and explained she attempted to stop the vehicle south of Jupiter Key which is approximately 0.75 miles from where the vehicle finally pulled over. While behind the white truck with emergency lights and sirens activated in a fully marked Jupiter Police vehicle, the truck had continued going north and was swerving all over the roadway. After the truck pulled over, Ofc. Irons stated the driver exited and was unable to stand up and nearly fell. Ofc. Irons detained the male and placed him into handcuffs and had him sit on the ground until other officers arrived. At this time I made contact with the original 911 caller who was positively identified by FL DL to be


WM Edward S. Towne (1/26/70). Towne told me the following in a sworn verbal statement:

Towne explained while exiting I95 on Donald Ross Road he observed a white pickup truck towing a boat and trailer going east on Donald Ross Road and stated the truck was all over the roadway. Towne stated the truck nearly left the roadway and he called 911. The truck then turned north on S US Highway 1 approaching Marcinski. While sitting at the light the truck made a right turn from the left lane on a solid red light. The truck then turned north on S A1A and was still all over the roadway and nearly hit several pedestrians and continually went into oncoming lanes.

I then made contact with the driver of the pickup who was positively ID'd by FL DL to be WM Cody C. Wolfe (9/29/89). Wolfe was seated on the curb on the side of the road and as I approached him I noticed the strong odor of an unknown alcoholic beverage coming from his person. Wolfe had glassy eyes and appeared to be groggy. Wolfe was read his Miranda Warnings from a preprinted card and stated he understood each right. Wolfe had very mumbled and slurred speech. Wolfe was asked what was going on today and he refused to answer the question. Wolfe was asked if he was going to speak to me which he stated no. Based off of the witness statement from the 911 caller, Ofc. Irons statement of the driving pattern, and my personal observations up to this point I informed Wolfe that I thought he may be impaired and I asked him to conduct Standardized Field Sobriety Tasks (SFSTs). Wolfe refused to complete the SFSTs. I then informed Wolfe that his refusal to complete the SFSTs can be used against him in court and that he was forcing me to make a decision on if I believed he was too impaired to drive based off of my investigation to this point. Wolfe again refused to complete SFSTs.

Based on my entire investigation to this point including the witness statement from the 911 caller, Ofc Irons statement, and my personal observations of Wolfe, I developed probable cause to arrest and charge Wolfe with DUI pursuant to Florida State Statutes. Wolfe was explained he was under arrest for DUI and for Flee and Elude from a marked police vehicle with emergency lights and sirens activated. It should be noted that Wolfe was extremely unsteady on his feet and had to be assisted in walking forward by officers. Wolfe was placed into the back seat of my patrol vehicle and secured by the seat belt after a search of his person yielded negative results. After securing Wolfe in my patrol vehicle, I conducted a search of his vehicle for any contraband which yielded negative results. After a short time I returned to my patrol vehicle which had a rear window down next too Wolfe and opened the drivers door. Upon opening the door there was a strong odor of an unknown alcoholic beverage coming from the vehicle. This odor remained even after Wolfe was removed from the vehicle at the jail.

Wolfe was transported to the Palm Beach County Jail BAT Facility and after completing the 20 minute observation period, Wolfe refused to provide a breath sample. Wolfe was read implied consent from a preprinted paper and stated he understood but again refused to provide a breath sample. Wolfe was then read his Miranda Warnings from a preprinted

Wolfe was placed in a holding cell while the appropriate paperwork was completed. Wolfe was later turned over to the Palm Beach County Jail without incident.

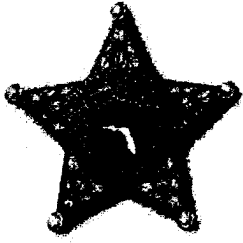
