The defendant was still seated in the driver's seat of his vehicle as officers arrived on scene. The defendant was driving his red Jeep Wrangler, bearing FL tag RMF959. Upon making contact with the defendant, he displayed multiple indicators of impairment, including: slurred speech, a strong odor of an alcoholic beverage on his breath, bloodshot/glassy eyes, and post-Miranda admission to consuming alcoholic beverages. The defendant exhibited multiple clues of impairment during the SFSEs and was arrested for DUI. The defendant later submitted to the breath test, which had a BrAC of .178/.184.
