The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did
 On Saturday January 23, 2021, I, Officer Malachi Wilkins of the Florida Fish and Wildlife Conservation Commission was on state land patrol in Hillsborough County, Florida. At approximately 1725 hours I observed a blue boat being operated by the defendant at Williams Park Boat Ramp. As the defendant was tying off to the dock, I approached him and identified myself and the reason for the stop. At the time the defendant was operating the boat there were fishing rods onboard and no valid vessel safety inspection decal affixed to the boat. I informed the defendant that I was going to conduct a vessel safety and resource inspection. During the inspection the defendant had bloodshot and watery eyes. He also had the strong odor of an alcoholic beverage coming from his person. At the conclusion of my inspection I asked the operator had much alcohol he had consumed, and he said, "5 beers." I then asked the defendant if he would consent to performing Seated Field Sobriety Tasks (SFSTs). The defendant stated that he would do. While utilizing a stable platform for the SFSTs the defendant performed poorly on them. I then placed the defendant under arrest and read him Implied Consent. He refused to provide a sample of his breath. He was transported to Orient RD. Jail without incident.
