

S T A T E M E N T	On 8/18/2021 at approximately 2338 hours, I responded to Southern Blvd and Parker Ave in reference to an accident with injuries. Upon arrival, I made contact with Colette Peigne, who was in the rear of 901 Southern Blvd (Subway). Laying on the ground was the victim, Kayla Daniel, crying in pain. West Palm Beach Fire Rescue 2 arrived and tended to Daniel, who was transported to St. Mary's Hospital.						
	Peigne told me the following. Peigne was in a vehicle, a 2020 Mercedes 4-door sedan FL tag QKC-P58, following a friend of hers. When in the rear parking lot of Subway, Daniel exited the rear passenger door of her friend's vehicle. Peigne then struck Daniel and was going to continue following her friend. Peigne said the friends name is Tavian, but would not provide any other information, and he was driving an Infiniti. Peigne exited the parking lot and traveled southbound on Parker Ave across Southern Blvd. Peigne then turned around realizing she struck Daniel and went back to the scene. When Peigne arrived, she asked Daniel if she needed to call police, but Daniel had already called.						
A D M I N I S T R A T I V E	Officer Mathura responded to St. Mary's. Daniel was at the movies with Kevin (unknown last name) downtown in West Palm Beach. They left the movies in Kevin's vehicle, described as an older blue 4-door sedan, and were on the way to Kevin's house (unknown location). While on the way to Kevin's, they were at an unknown location when Peigne started running towards the Kevin's vehicle on foot. Kevin left the area, and Peigne started following them. Kevin got on I-95, driving in an unknown direction, and got off on Southern Blvd. Peigne was driving on Kevin's bumper the entire way. When going eastbound on Southern Blvd, Kevin pulled into Subway. Kevin slowed down and told Daniel to get out of the car because Peigne was chasing them. Daniel exited the rear passenger side of the vehicle and was struck by Peigne by the hedge line in the rear parking lot closest to Parker Ave. Daniel said it was intentional and believes Peigne accelerated the vehicle towards her. Kevin got out and checked on Daniel. Kevin and Peigne started arguing and Kevin left the area. Peigne stayed on scene.

	<p>In a post Miranda interview, Peigne told me the following. Peigne and Kevin have been dating since January of 2021. Peigne was trying to contact Kevin, but he wasn't answering. Peigne had an extra phone charger, so she went to Kevin's house. Peigne would not provide a location but said it was nearby Subway. When Peigne arrived, Kevin was not there. Peigne waited a bit and Kevin drove by. Kevin did not stop at his house, so Peigne started following him. Kevin pulled into Subway and went around the rear of the building. Daniel exited the rear passenger door and Peigne struck her as she was still following Kevin. Peigne exited the parking lot and traveled southbound on Parker Ave across Southern Blvd. Peigne then turned around realizing she struck Daniel and went back to the scene. When Peigne arrived, she asked Daniel if she needed to call police, but Daniel had already called. Peigne does not know Daniel and has never seen her before.</p> <p>At the scene, there was a tire mark in the dirt by the hedgerow near where Daniel was struck. The tire appeared to have jumped the curb off the road. A small bush had damage and there were weeds under the front driver's side of the vehicle Peigne was driving.</p> <p>Officer Mathura advised that Daniel suffered a dislocated left femur.</p> <p>Peigne later advised that Kevin's last name was Palacios. I attempted to contact Palacios several times with negative results.</p> <p>Due to the above information, I find probable cause that:</p> <p>Colette Peigne did actually and intentionally touch or strike Kayla Daniel, against the will of Kayla Daniel, and in doing so used a vehicle, a deadly weapon, contrary to Florida Statute 784.045(1)(a)2 and (2).</p>
