The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:
 On September 21, 2020 HCSO received a 9-1-1 call from apartment complex security advising a male was "passed out" in a Mazda CX5 license plate#:ITYL35. Deputies responded, and were shown a blue Mazda CX5 bearing Florida license plate#: ITYL35 (VIN: JM3KFBBL4H0217080) and made contact with the defendant (Driver) who was unconscious in the driver's seat with the vehicle running. Deputies woke the defendant up with a sternum rub. Previous attempts to wake him by touching him were unsuccessful. Upon waking the defendant Deputy J. Smith ABN#: 253004 observed the defendant to have glossy eyes, to be confused, and to have slurred speech. Deputy T. Ryan ABN#: 257245 observed the defendant to have glossy eyes and he detected the odor of an alcoholic beverage emanating from the defendant's breath. I made contact with the defendant and observed him to have bloodshot watery eyes, slurred speech, to be unsteady on his feet, and I detected the strong odor of an alcoholic beverage emanating from his breath. The defendant refused to perform standardized field sobriety exercises. Post Miranda the defendant stated he consumed liquor and when he got in his vehicle he knew he couldn't drive. During an inventory search of the vehicle, I located one 750ml empty bottle of Skyy Vodka, one almost empty 750ml bottle of Skyy Vodka, and two mostly full 1.75 liter bottles of Skyy Vodka in a gym bag on the passenger side floor board. I also located a small baggie of marijuana in the same bag. Once at Central Breath Testing, after being advised of the Implied Consent Warning, the defendant refused to provide lawful breath samples. Per DAVID the defendant has a prior refusal to submit to lawful test of breath, urine, or blood from 09/18/2017 reference citation#: A8HL7ZE (Hillsborough County). I confirmed the defendant's identity via DAVID.

Pursuant to Florida Statute §92.525 and under penalties of perjury, I declare that I have read the foregoing document and the facts stated in it are true to the best of my knowledge. For Notices to Appear, I also certify that a complete list of witnesses and evidence known to me is attached.
