The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did

On the listed offense date, time, and location, your affiant and multiple HCSO Deputies were on scene of a serious traffic crash with injuries (HCSO 21-18267) that required a stretch of roadway be shut down. Several marked HCSO patrol vehicle with emergency lights activated were blocking the roadway at Lithia Pinecrest Rd / Lumsden Rd E. The defendant (Colleen Orender) was observed operating her 2013 Red Kia Soul bearing FL Tag #GLEZ85 when she drove around the marked patrol vehicles and began to drive into the crash scene. Multiple deputies yelled to get the defendant to stop but was unsuccessful. Deputy Tapolyai #256595 was able to get the defendant stopped at Durant Rd just before she drove onto the scene. Upon contact, Deputy Tapolyai detected indicators of impairment. Your affiant was already on scene and also made contact and detected multiple indicators of impairment such as the strong odor of an alcoholic beverage, slurred speech, and watery & glassy eyes. The defendant was requested to exit the vehicle which showed she was unsteady on her feet. Your affiant requested she perform roadside Field Sobriety Exercises (SFSE) to which she refused. The defendant was explained that a determination would be made if she still refused, and she elected to refuse the exercises. Miranda warnings were read and the defendant invoked her rights to remain silent only advising her brother was a lawyer. The defendant was arrested on scene for DUI. The defendant was transported to CBT where she refused to provide a breath sample to determine her alcohol content. Implied Consent warnings were read and she still refused to provide a breath sample. The defendant was positively identified via Florida Driver License.
