The undersigned swears that he/she has reasonable grounds to believe that the above named defendant on the 06 day of MARCH, 2020,

at approximately 2:18 AM, at BRYAN DAIRY RD / BELCHER RD, in Pinellas County did:

REASON FOR STOP: WHILE TRAVELING SOUTH ON BELCHER RD, NEAR BRYAN DAIRY RD, I OBSERVED A BLACK FORD F-150 (CQY8344) FAIL TO MAINTAIN A SINGLE LANE. THE VEHICLE WAS TRAVELING IN THE FAR RIGHT CURB LANE AND DRIFTED OVER THE DIVIDING LANE LINE, NEARLY STRIKING THE SIDE OF MY PATROL CRUISER. I WAS FORCED TO BRAKE AND SLOW IN ORDER TO AVOID WHAT APPEARED TO BE AN IMMINENT COLLISION. AS I FOLLOWED THE VEHICLE FOR A SHORT DISTANCE, IT CONTINUED TO DISPLAY THE SAME CONCERNING DRIVING PATTERN. AT ONE POINT THE VEHICLE DRIFTED OVER THE SOLID FOG LINE AND STRUCK THE RAISED CURB. I INITIATED A TRAFFIC STOP TO ENSURE THE DRIVER WAS NOT SICK, INJURED OR IMPAIRED. THE DRIVER WAS IDENTIFIED AS COLLIN HORNYAK.

THEN AND THERE UNLAWFULLY DRIVE AND/OR BE IN ACTUAL PHYSICAL CONTROL OF A MOTOR VEHICLE WITHIN PINELLAS COUNTY, FLORIDA WHILE UNDER THE INFLUENCE OF AN ALCOHOLIC BEVERAGE, A CONTROLLED SUBSTANCE AND/OR ANY CHEMICAL SUBSTANCE TO THE EXTENT THAT HIS NORMAL FACULTIES WERE IMPAIRED.


ADVISORY AND SOLVENCY HEARING

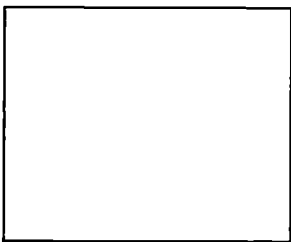
