The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did

The defendant was driving a red 2019 Dodge Ram bearing a Florida license plate of B1HNC. He was traveling south on S Armenia Ave at about W North B St. The defendant came to a screeching stop for no reason, then sped up and swerved from the far left lane to the far right lane and then back and forth several times (failing to maintain a single lane). He did this while cutting off another vehicle in what appeared to be a road rage incident. The defendant then turned east onto Kennedy Blvd and accelerated very quickly. He traveled at 55 MPH in a 40 MPH zone while swerving back and forth in his lane. A traffic stop was made and the defendant made a right turn onto S Rome Ave and struck the curb. Upon making contact with the defendant he displayed multiple indicators of impairment, to include; watery and bloodshot eyes, droopy eyelids, slurred speech, a strong odor of an alcoholic beverage, and an unsteady walk. The defendant provided his passport card when I requested his drivers license. He also fumbled with paperwork when trying to find his registration. The defendant performed SFSEs and multiple clues of impairment were observed. The defendant was arrested for DUI and later refused to submit to a breath test despite acknowledgment of the Implied Consent Warning.

The defendant was identified by his FL DL.
