 The defendant, who was identified by his Florida driver's license, was stopped for making a right turn on a red light where prohibited. The defendant had watery eyes and a strong odor of an alcoholic beverage emitting from his breath. The defendant admitted consuming alcohol prior to driving. While checking the defendant's eyes I observed 6 point nystagmus and also observed that he swayed back and forth continuously. Defendant agreed to perform additional SFST's, but while he was being given the instructions for the walk and turn exercise he was unable to maintain his balance on the line. The defendant then decided not to continue with the exercise. The defendant was arrested for DUI and transported to CBT where I read him implied consent. The defendant refused a breath test. This occurred in Hillsborough County, Florida.
