The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did
 The defendant was driving a white 2020 Land Rover bearing a Florida license plate of NTAW92. She was traveling east on Kennedy Blvd near S MacDill Ave and was weaving back and forth in her lane, striking a curb at one point. A traffic stop was made and upon making contact with the defendant she displayed multiple indicators of impairment, to include; watery and bloodshot eyes, droopy eyelids, slurred speech, an odor of an alcoholic beverage, unsteady stance, and an admission to consuming alcohol. The defendant performed the horizontal gaze nystagmus and walk and turn exercise but refused to do the one leg stand. Multiple clues of impairment were observed during the SFSEs. The defendant was arrested for DUI and later refused to submit to a breath test, despite acknowledgment of the Implied Consent Warning. The defendant also has a prior refusal to submit to testing on 11/10/2016.

The defendant was identified by her FL DL.
