The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did
 On October 17, 2020 on Bearss Av. E. at Nebraska Av. N. I observed a cream Toyota Tacoma bearing Florida license plate#: AWWA63 (VIN: 5TETU62N75Z031752) leave the roadway with it's driver's side wheels at the railroad tracks. I then paced the vehicle traveling at 60 MPH in a posted 45 MPH zone. I conducted a traffic stop on the vehicle and we came to a final rest in a parking lot at the intersection of Bearss Av. E. and 30th St. N. Prior to approaching the driver's side window, I detected the odor of an alcoholic beverage emanating from the vehicle. Upon contact with the defendant, driver, I detected the strong odor of an alcoholic beverage emanating from his breath, I observed his eyes to be bloodshot and watery, and I observed his pupils to be dilated. The defendant spontaneously stated, " Just arrest me. I'm sorry." I also observed an open 16oz Budlight can in the center console cup holder. I requested the defendant perform standardized field sobriety exercises to which he refused. During an inventory search of the vehicle, I located an open 16oz can of Budlight in the center console cup holder, cold and sweating. I also located two more full cans on the passenger seat, cold and sweating. Once at Central Breath Testing, the defendant provided lawful breath samples showing a breath alcohol concentration of .163/.166. I confirmed the defendant's identity via DAVID.
