The defendant was found passed out behind the wheel of his vehicle, with the engine running and in gear, with his foot on the break. The defendant was in actual physical control of his 2009 Toyota 4dr, bearing FL tag #CFAF94, which was stopped in front of a gas pump at the listed location. Upon making contact with the defendant, he displayed several indicators of impairment, including: slurred speech, a strong odor of an alcoholic beverage on his breath, bloodshot/glassy eyes, sluggish reflexes, and difficulty answering simple routine questions. The defendant performed poorly on the SFSEs and was arrested for DUI. The defendant later refused to submit to the breath test, despite having been advised of the Implied Consent Warning.

The defendant identified himself via his FL driver's license.
