The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did
 On 02/27/2021, at approximately 0332 hours, at the intersection of Causeway Blvd and Falkenburg Rd, Deputy Nagen (ABN 257646) contacted the defendant on a traffic stop for failing to stop at the traffic light. The defendant emitted an odor of an alcoholic beverage from his breath, had slurred speech, bloodshot watery eyes, and he had unstable balance. Standardized Field Sobriety Exercises were conducted and impairment was observed. Based on the totality of the investigation, the defendant was arrested for DUI and refused to provide two lawful breath samples. I advised the defendant of the Implied Consent warning in CB-01 room in CBT, where he still refused (see video). Subsequently, I completed the Affidavit Of Refusal To Submit To Breath Test. The defendant was charged with a previous DUI on 10/19/2012 and plead no contest. The defendant was positively identified via a Florida DL photograph.
