The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:

The defendant was driving a white 2010 Mercedes four door bearing a Florida license plate of LEGM40. She was traveling west on Kennedy Blvd between S Lois Ave and S Westshore Blvd and was paced traveling 62 MPH in a posted 40 MPH zone. In addition, the vehicle was weaving back and forth. A traffic stop was made and upon making contact with the defendant she displayed multiple indicators of impairment, to include; watery and bloodshot eyes, dilated pupils, slurred speech, an odor of an alcoholic beverage, unsteady stance, body tremors, and an admission to consuming alcohol. The defendant performed SFSEs and multiple clues of impairment were observed. The defendant was arrested for DUI and later refused to submit to a breath test, despite acknowledgment of the Implied Consent Warning. In a search, incident to arrest, two pills (one white oval pill and one yellow oval pill both marked "T259") were located in a ziploc bag, inside of a cosmetic bag on the passenger seat. Both pills were identified as Hydrocodone via Drugs.com. The defendant was the only person in the vehicle.

The defendant was identified by a DAVID photo.
