On the 28 day of February, 2021 at 00:28 (Specifically include facts constituting cause for arrest.)

On 2/27/21, at approximately 2347 hours, I responded to the area of 701 W Palmetto Park Rd in reference to a single vehicle traffic crash. Upon arrival, I observed a black 2012 Honda Civic (FL - ILI294) with heavy front end damage. The vehicle was on the raised center median and showed obvious signs of having struck a damaged street sign and a tree that were directly in front of it. As I approached the vehicle, I witnessed a W/F exit the vehicle from the driver seat. The female was identified as Courtney Isgette by FL DL. Isgette had a bloody upper lip and several other small scrapes across her body consistent with having been involved in a crash. Additionally, only the steering wheel airbag deployed indicating that she was the only person inside of the vehicle and, therefore, the driver of the vehicle at the time of the crash.



When Isgette stepped out of the vehicle I observed that she had poor balance, red and glassy eyes, and slurred speech. I could also smell a strong odor of alcoholic beverage emanating from Isgette's breath when she spoke. While speaking with Isgette I noticed that she had difficulty following simple instructions and was unable to stay focused on one thing. On several occasions, I asked Isgette questions which she responded to with completely irrelevant answers. Isgette was offered medical assistance from BFRF numerous times and she refused treatment on every occasion.

Upon completion of the crash investigation, I informed Isgette that the crash investigation was complete and that I would be conducting a criminal DUI investigation. Isgette stated that she understood. I then advised Isgette of her constitutional warnings and she stated she understood those too.

I asked Isgette where she was coming from and she stated she was on her way home from an unknown bar in Deerfield Beach. I asked Isgette if she consumed any alcohol while at the bar and she confessed to consuming a "ginger drink" which contained Tito's Vodka. Isgette stated she was not sick, injured, diabetic, or epileptic. she also stated she

P R O B A B L E	<p>felt comfortable in her shoes, did not limp, and did not have anything wrong with her eyes that is not corrected by glasses or contacts. I then asked Isgette to submit to Standardized Field Sobriety Exercises and she agreed to participate.</p> <p>The first exercise was Horizontal Gaze Nystagmus. I administered the instructions and Isgette stated that she understood. I observed that Isgette moved her head and also momentarily took her eyes off the stimulus while the exercise was being conducted. She also swayed in a circular motion and lost her balance causing her to fall out of position.</p> <p>The second exercise was the Walk and Turn. I administered the instructions and demonstrated how the exercise should be completed. I noticed that Isgette had some difficulty getting into and staying in the starting position. She also attempted to begin the exercise before being told to do so. Once the instructions were completed, Isgette stated that she understood. Isgette missed heel to toe on every step, used her arms for balance, stepped off the line and never completed a turn. She also walked the entire line around the center median until she was unable to continue due to a BRFR truck blocking the way.</p> <p>The third exercise was the One-Leg Stand. I administered the instructions and demonstrated how it should be completed. Isgette stated she understood. Isgette swayed in a circular motion, used her arms for balance, and put her foot down several times during the exercise.</p> <p>The fourth exercise was the Finger to Nose. I confirmed that Isgette knew her left from her right by asking her to show me her left hand and then her right hand. I then administered the instructions. The pattern was L-R-L-R-R-L.</p> <p>L - Moved her head to the left and never raised her hand. R - Moved her head to the right and never raised her hand. L - Moved her head to the left and never raised her hand. R - Moved her head to the right and never raised her hand. R - Moved her head to the left and then back to the right. Never raised her hand. L - Moved her head to the left and never raised her hand.</p> <p>The final exercise was the modified romberg balance test. I asked Isgette if she felt comfortable estimating the passage of 30 seconds and she stated she did. I demonstrated the passage of 30 seconds using a stop watch. The instructions were administered, and the exercise was conducted. Isgette estimated the passage of 30 seconds in 88 seconds. She also swayed in a circular motion and lost her balance causing her to fall out of position while the completing the exercise.</p> <p>Based on my observations, Isgette's statements, and the totality of the circumstances, I</p>

found probable cause to believe that, at the time of the crash, Isgette was operating a vehicle within the state while under the influence of drugs or alcohol to the extent of impairment. Isgette was placed under arrest per F.S.S. 316.193(3c1). She was transported to the Palm Beach County Sheriff's Office DUI Testing Facility where Breath Operator Leahey (#19183) completed the BAT room procedures. Isgette refused to provide a breath sample. She was informed of implied consent and again refused to provide a breath sample. Isgette was then advised of her constitutional warnings and stated she understood. Isgette refused to answer any questions. See DUI Influence Report for further.

It should be noted that while at the BAT, Isgette made a spontaneous utterance stating that she consumed two glasses of wine which conflicted with her earlier statement of having consumed a drink containing vodka.

Isgette was medically cleared at Boca Raton Regional Hospital and later turned over to PBSO at Palm Beach County Jail.

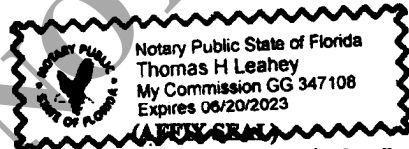

I informed the driver that the refusal to submit to such test(s) would result in the suspension of his or her driving privilege for a period of one (1) year for a first refusal, or for a period of eighteen (18) months if his or her driving privilege had been previously suspended for refusing to submit to a breath, urine or blood test. I also informed the driver that he or she commits a misdemeanor by refusing to submit to a lawful test as requested above if his or her driving privilege has been previously suspended for refusal to submit to a lawful test of his or her breath, urine, or blood. Additionally, I informed the driver that if he or she holds a CDL, or was operating a CMV, refusal will result in the disqualification of the Commercial Driver's License/driving privilege for a period of one (1) year in the case of a first refusal or permanently if he or she has previously been disqualified as a result of a refusal to submit to any such lawful test. Nonetheless, the driver refused to submit to the test(s) requested.
