The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:

The defendant caused a crash with property damage when she failed to maintain her lane of travel and side-swiped the victim's vehicle. The defendant was driving her 2018 Ford Explorer, bearing FL tag JRMR12. Upon making contact with the defendant, she was still seated in the driver seat of her vehicle and the victim positively identified as the driver at the time of the crash. The defendant exhibited multiple clues of impairment, including: slurred speech, a distinct odor of an alcoholic beverage on her breath, bloodshot/glassy eyes, possession of an open container of vodka, and post-Miranda admission to consuming alcoholic beverages. The defendant exhibited 6 out of 6 clues of impairment during the SFSEs, but refused to perform the remaining SFSEs. The defendant was arrested for DUI with property damage. The defendant later submitted to the breath test, which had a BrAC of .190/.185.

The defendant identified herself via her GA DL.
