The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:
 On 08/18/20, at approximately 1502 hours, the defendant was in physical control of and passed out behind the steering wheel of a 1999 Ford SUV Florida tag: HZYA88. This vehicle was parked with the passenger side tires on a curb. An open bottle of "Jim Beam" was located on the dashboard of the listed vehicle and the defendant spontaneously stated she did drink earlier. I immediately noticed the odor of an alcoholic beverage coming from the defendant's person and breath, while wearing a surgical mask. When the defendant spoke she did so while slurring her words. I also noticed the defendant to have blood shot and watery eyes. When the defendant exited the vehicle I noticed she was unsteady on her feet and staggered when she walked. The defendant was offered the opportunity to perform the FSEs where she did not satisfactorily perform them. The defendant did provide a sample of her breath with the results of .067 and .066. The defendant was identified by a valid Florida Driver's License.
