 On 11/07/2020, at approximately 0140 hours, I responded to 14036 301 Hw S. Riverview, Fl. 33578 in reference to a Domestic -Non Violent, call for service. Call notes related the following, "CP ADVING HER MOTHER WF CRISCYNDA REVIERE IS DRIVING ERRATIC IN THE NEIGHBORHOOD...DRIVES A 2012 NISSAN ALTIMA....UNK TAG...POSSIBLY ON MEDS AND WAS ARGUING WITH CP OVER HER MEDS". Deputy Riendeau (ABN:256737) located the vehicle (Y653CN/VIN:1N4AL21E78N523988) and made a consensual encounter with the defendant, who was in the driver's seat, with the keys in the passenger seat. The defendant was found parked in a school parking lot. Deputy Riendeau observed indicators of impairment. When I arrived on scene, I made contact with the defendant and observed her to have watery/glassy eyes, slurred speech, raspy voice, erratic movements, unstable on her feet. The defendant elected to perform the standardized field sobriety exercises, and doing so, I observed more indicators of impairment. The defendant spontaneously stated she was under the influence of adderall, Xanax, Oxycodone, and Methanol. At Central Breath Testing, at Orient Road Jail, the defendant provided lawful breath samples after a twenty minute observation. The breath results were recorded at .000 and .000. The defendant elected to provide a lawful urine sample. The defendant identified herself via Florida driver's license.
