On 8/2/2020 at 12:42 a.m. I, FTO Melinda Hanton and Officer Amanda Wood, responded to 4217 Honeysuckle Avenue, in reference to an intoxicated female. Upon arrival I activated my department issued body camera and made contact with Officer Kristen Garito. Officer Garito advised that they responded to the residence for a disturbance, the female resident, Cristina Dragos, appeared intoxicated and was advised to not drive and go in the house. Dragos went in the house, then exited with the car keys. Dragos entered the black truck and started the engine and put the truck in reverse, when Officers stopped Dragos from leaving. A computer check shows Dragos does not have a license.

OBSERVATION OF DRIVER:

Dragos has an odor of an unknown alcoholic beverage coming from her breath as she spoke, her speech has an accent and sounded slurred at times, she was unsteady on her feet swaying and stumbling the entire time. Her eyes were glassy.
