The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 10-10-2021, at 2352 hours, Tampa Police Officer Frueh #107 was completing his shift for service when he observed the defendant involved in a domestic altercation at 5905 Trace Meadow Loop, at the front of the apartment complex, HCSO case 21-679842. Officer Frueh observed the defendant sitting in the driver seat of a parked, running red Chevrolet Camaro (keys in ignition) bearing FI tag KYCK66 and VIN 2G1FA1ED5B9128857, as she was arguing with her boyfriend. Officer Frueh separated both parties and upon making contact with the defendant, observed her displaying indicators of impairment. Deputy Gibb #257675 responded to the scene to take over the domestic disturbance investigation and also observed the defendant displaying indicators of impairment. The indicators of impairment observed include, bloodshot glassy eyes, slurred speech, was unsteady on her feet and I detected the odor of an alcoholic beverage emanating from the defendants breath. The defendant agreed to perform field sobriety exercises and impairment was detected. The defendant was arrested for DUI and provided a lawful sample of breath (.250) and (.250), after a twenty minute observation period. The defendant was identified via her Florida drivers license.
