The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:

On 6/5/2021, at approximately 10:56 PM, I was dispatched to a single vehicle crash on US-41 (SR-45) north of 7th Street NW. I arrived on scene at approximately 11:22 PM. I spoke to deputies on scene and was informed that the single vehicle, a white 2004 Ford Explorer Sport Trac (FL Tag# BAWA66) was southbound and had struck the median curb and crossed into the northbound lanes where it rolled onto its side. I walked the scene and it was consistent with that description. I received the driver's license from the deputies and identified the driver by the photo on her driver's license as Crystal Gayle Worth (FL DL# W630107815220). I spoke to the Ms. Worth and she said that she just lost control of the vehicle coming from the store. I observed Ms. Worth to have watery bloodshot eyes and smell commonly associated with alcoholic beverages emitting from her breath. I then requested that Ms. Worth perform Standard Field Sobriety Exercises (SFSEs) and she agreed. After completing the Horizontal Gaze Nystagmus exercise unsatisfactorily, Ms. Worth claimed she had prior injuries that would prevent her from doing the Walk and Turn and the One Leg Stand. At approximately 11:58 PM, I placed Ms. Worth under arrest for driving under the influence. Ms. Worth was searched by a female Deputy on scene and placed into the back of my patrol car. At approximately 12:36 AM, on 6/6/2021, I transported Ms. Worth to the Hillsborough County Jail on Orient Road. I arrived at approximately 1:07 AM and brought Ms. Worth to Central Breath Testing. I requested that Ms. Worth provide a breath sample and she agreed. After a waiting period of at least 20 minutes, Ms. Worth provided two samples, 0.151 g/210L and 0.153 g/210L. Ms. Worth was then turned over to the Hillsborough County Jail Staff for booking.

All events occurred in Hillsborough County. Crash investigation, SFSEs, and transport were all recorded on the mobile video recorder onboard FHP1799.

Pursuant to Florida Statute §92.525 and under penalties of perjury, I declare that I have read the foregoing document and the facts stated in it are true to the best of my knowledge. For Notices to Appear, I also certify that a complete list of witnesses and evidence known to me is attached.
