The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On the listed date and time the defendant was a front seat passenger in a stolen black Chevrolet Suburban bearing VIN:3GNFK16Z03G131498. Pasco County Sheriff's Office Deputies had already been in pursuit of the listed vehicle. The vehicle became immobilized by intentionally ramming a marked Pasco Sheriff's Office patrol vehicle. At that time the defendant exited the passenger seat of the vehicle and fled on foot through the parking lot. The defendant was given numerous loud verbal commands such as, "Stop, Police!" by several uniformed Pasco Deputies and Tampa Police Officers wearing tactical vests with POLICE insignia on the front and back. The defendant ignored these commands and continued to run, but was apprehended a short distance away. The defendant identified herself verbally which was confirmed via RMS.
