*****Supplemental P/C***** On 03/03/22 at approximately 2245 hours, I located a blue Nissan Rogue (FL tag 580 NDA) traveling north bound (curving east bound) in the 800 block of Hibiscus Dr driving with not lights on. The Nissan drove approximately one half mile on the wrong side of the roadway with no lights on. The Nissan was breaking for no reason and at one point came to a complete stop for no reason. The Nissan turned their lights on as they approached Royal Palm Beach Blvd. The Nissan turned south on Royal Palm Beach Blvd in front of another vehicle almost causing a vehicle crash. I then activated my lights and sirens in my PBSO issued unmarked patrol vehicle and the Nissan pulled over. The driver, and sole occupant, was Crystal Vargas. Vargas had very slurred speech and was rambling on about loving her ex-husband of 30 years. I asked Vargas if she knew why I stopped her and she replied, "cause I fucked up". I explained I stopped her for driving with no lights on and driving on the wrong side of the road. Vargas originally stated she did not know where her driver's license was but then pulled her purse up to the front from the back seat. Vargas located her driver's license after an abnormal amount of time. Vargas was given more time to located her registration and insurance. Vargas located her registration from 2021 and she was advised that this is the year 2022. Vargas continued to stated that she "fucked up". I called a PBSO DUI deputy Amadon 9440 to the scene to conduct a DUI investigation.
