at approximately 12:46 AM, at 4125 PARK ST. NORTH LOT 630, ST. PETERSBURG FL, 33, in Pinellas County did:

THE DEFENDANT DID ACTUALLY AND INTENTIONALLY TOUCH OR STRIKE CHRISTOPHER SCHALLER, HER HUSBAND AND CO-HABITANT, AGAINST HIS WILL, TO-WIT: THE DEFENDANT SCRATCHED THE VICTIM IN THE FACE AND PULLED HIS HAIR WITH HER HANDS.

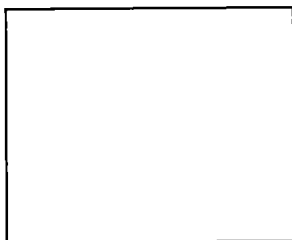
