D.U.I. PROBABLE CAUSE AFFIDAVIT

PERSONAL CONTACT

DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

The following occurred in the City of Delray Beach, County of Palm Beach, FL.
On 02/20/20 at 2238hrs, Ofc. Reed DBPD observed a white 2019 Dodge Challenger turn southbound onto NE 5th Ave. from NE 4th St. The Dodge approached the intersection at NE 2nd St. and fail to stop for a steady red traffic signal. The Dodge continued south at a high rate of speed (Ofc. Reed pace at least 50+mph). Ofc. Reed conducted a traffic stop on the Dodge in the 1st block of NE 5th Ave. and observed a white male driver. Ofc. Reed identified the white male driver by his FL DL as Damien Gabriel Maloney. Maloney was the sole person inside the Dodge, with the engine running and the ignition key/fob inside the Dodge. Ofc. Reed observed signs that Maloney may be under the influence and had Maloney exit the vehicle prior to my arrival. I arrived on scene to conduct a DUI investigation. I notified Maloney who I was and I was on the scene to conduct a DUI investigation. I checked Maloney's driving record in D.A.V.I.D. and his record had one previous DUI / Refusal to Submit to Breath, Urine or Blood in 2012.

OBSERVATION OF DRIVER:

I smelled a strong odor of an unknown alcoholic beverage coming from Maloney. Maloney had red and glassy eyes. Maloney was slightly unsteady standing under his own power. Maloney answers to my questioning was not consistent. Maloney laughed several times during questioning and roadsides. Maloney would stop laughing after I instructed him to remain still during roadsides.

DRIVER'S STATEMENTS:

Maloney stated he was on his way to Hurricanes Bar and Lounge located at 640 E. Atlantic Ave. in Delray Beach, FL. Maloney stated he was coming from his parent's residence at 12620 Oak Arbor Ln. in Boynton Beach, FL. prior to the traffic stop. I questioned Maloney about the strong odor of an unknown alcoholic beverage coming from his person and he replied the odor came from two elderly females he drove to and from ballroom dancing lessons. Maloney stated these elderly females were intoxicated while they were inside the Dodge. Maloney initially stated to Ofc. Reed he had drank an alcoholic beverage at his parent's residence because he attended a birthday party. Maloney stated to me the last alcoholic beverage he consumed was at 7pm on 02/19/20. Maloney also stated he changed his clothing after dropping off the elderly females and before he left his parent's residence. Maloney did not have an answer when I questioned why his new set of clothing had an odor of an unknown alcoholic beverage coming from them. After I placed Maloney under arrest, he stated he did not know why he was under arrest because he passed the roadsides.

ODORS:

Maloney had a strong odor of an unknown alcoholic beverage coming from his person.

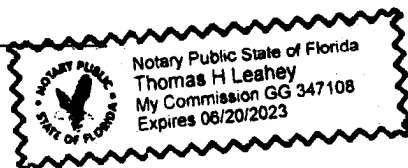

On 02/21/20 at 0010hrs Maloney refused to provide a breath sample at the PBCJ BAT.

Maloney lost his balance while I was demonstrating the roadside task. I instructed Maloney to remain still until I instruct him to begin. Maloney did not touch one step heel to toe and did not turn around as instructed. After Maloney turned around, he had to ask if he began with the number 1 before walking back. Maloney used his arms for balance during this roadside task.

ONE LEG STAND:

Maloney used his arms for balance during this roadside task. Maloney stopped counting without instruction to do so.

FINGER TO NOSE:

Maloney missed his nose with his index finger tip several times during this roadside task. Maloney used two fingers from the same hand several times to touch his nose. Maloney was slightly swaying while conducting this roadside task.

ROMBERG ALPHABET:

Maloney was slightly swaying during this roadside task. Maloney recited two wrong letters during this roadside task.

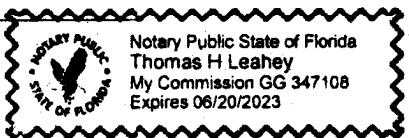

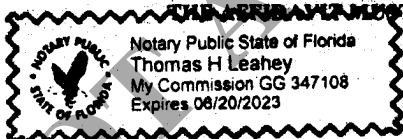

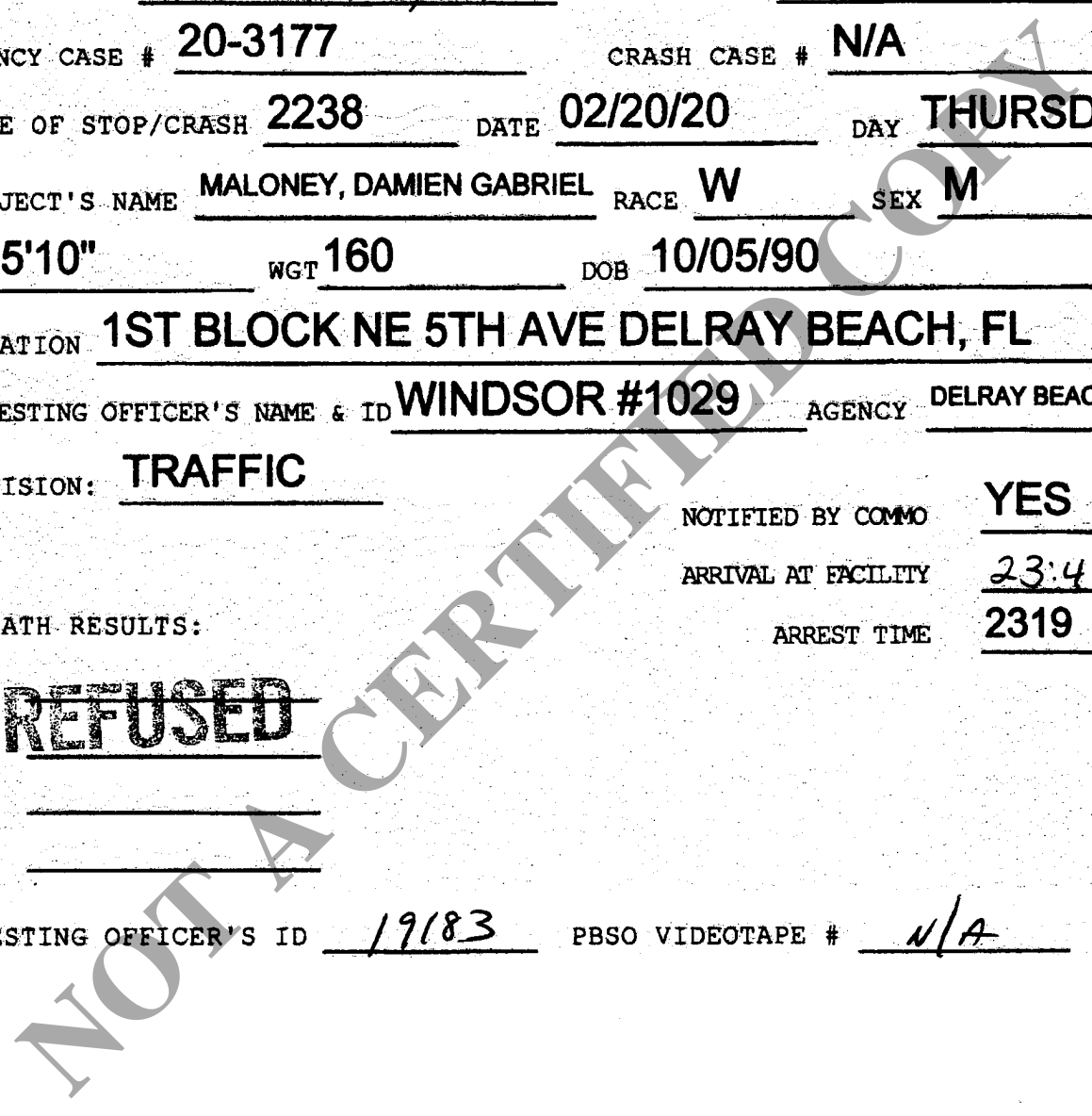
