The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 10/04/2020, at approximately 2221 hours, near the intersection of Highway 41 North and Big Bend Road, Apollo Beach, Florida 33572 the defendant was observed by an independent witness crashing her vehicle. Upon the affiant's arrival minutes after the traffic crash, I observed her to be in physical control of her vehicle, seated in the driver's seat with the vehicle running. I observed the brown 2015 Chevrolet Trax bearing Florida tag BULP31 with an assigned VIN of KL7CJLSB8FB110928 to have fresh damage in front of the vehicle. Accident Investigator Deputy A. Karpenske ABN: 249578 responded to the scene and completed a traffic crash (89439573). While in direct contact with the defendant, I observed multiple indicators of impairment. The affiant observed the defendant to have bloodshot watery/glassy eyes, slurred speech, disorientated, extremely unsteady on her feet, and I smelled the strong odor of an alcoholic beverage emitting from her breath. The defendant decide to participate in the field sobriety exercise and while doing so, she demonstrated further indicators of impairment. Post Miranda, the defendant admitted to consuming two alcoholic beverages prior to operating her motor vehicle. After taking the totality of the circumstances and the defendant's indicators of impairment into consideration, she was placed under arrest for DUI. The defendant was transported to Central Breath Testing and she provided two lawful breath samples of .114 and .120. As a direct result of the traffic crash, the defendant caused approximately \$15,000 of damage. The defendant identified herself verbally. I further identified the defendant via her DAVID photograph.
