committed the below acts in my presence. was observed by _____ who told _____ that he/she saw the arrested person commit the below acts.

confessed to _____ admitting to the below facts. was found to have committed the below acts, resulting from my (described) investigation.

On the **29** day of **August**, **2020** at **23:40** (Specifically include facts constituting cause for arrest.)

On August 29, 2020 at 1922hrs, I was dispatched to 342 Southwind Dr. in North Palm Beach Fl 33408, in reference to a disturbance call.

Upon arrival, I made contact with the victim, Carolina Morales (W/F 01/24/1969). Morales stated that she was at the community Pool with her Friend, who is a resident; when Dana Millard (W/F 06/01/1973) began yelling at her unprovoked. Morales stated that Millard was obviously intoxicated and was telling her to leave the pool because she was not a resident. After the verbal argument ended Millard hit Morales with a cup which left a mark on her left arm.

An independent witness, Adrienne Stegner (W/F 03/3/1971) stated that she saw the incident and corroborated Morales's story. Morales completed an affidavit of prosecution and Stegner completed a witness statement.

Based on my investigation and the totality of the circumstances, I find Millard in violation of F.S 784.03(1). The offense of battery occurs when a person actually and intentionally touches or strikes another person against the will of the other.

North Palm Beach Police Officers went to place Millard under arrest and she started to pull away preventing officers from placing handcuffs on her. North Palm Beach Police Officers had to redirect Millard to the ground where she tensed up her arms, stated she wasn't going to jail. North Palm Beach Police Officers were able to take control of her arms. Millard did resist, obstruct or oppose law enforcement officers of the North Palm Beach Police Department, in the execution of a legal process or in the lawful execution of a legal duty, without offering or doing violence to the person of such officer, contrary to Florida Statute 843.02.

Millard was placed under arrest (double locked) and secured in handcuffs. A female


