On August 4, 2020, at 0607 hours, Palm Beach Police responded to 2730 South Ocean Blvd., Palm Beach in reference to CAD # 2020-217031. Officer's met with a W/F identified as Dana Ruth Cannizzo who wished to report her vehicle missing. The investigation revealed that the vehicle was not stolen and that Cannizzo knowingly gave the vehicle to a friend. The vehicle still has not been returned.

On August 4, 2020, at approximately 1445 hours, this affiant conducted a knock and talk follow up investigation at 2730 South Ocean Blvd, Unit 207, Palm Beach. The door to unit 207 was answered by a white female who was positively identified as Cannizzo, who stated that the vehicle still had not been returned. While speaking with Cannizzo, she made reference to recently associating with males who were involved in narcotics. This affiant asked Cannizzo if there was any narcotics in unit 207. Cannizzo walked over to the kitchen counter and opened the top left drawer. Cannizzo then picked up a clear zip lock bag that contained a small amount of a crystal substance that this affiant believed was methamphetamine. This affiant then seized the bag which later field tested positive for methamphetamine using a NARK II test 15 field test kit. This bag had an approximate weight of 0.9 grams. This affiant also recovered two rolled up pieces of aluminum shaped as a "pipe" that was burnt. These "pipes" are suspected to be used to ingest the methamphetamine and were seized as evidence. Cannizzo was placed under arrest, Mirandized and transported to the Palm Beach County Jail for processing.

Based on this information, I determined that I had probable cause to arrest W/F Dana Cannizzo with one count of Possession of Methamphetamines in violation of F.S.S. 893.13(6)(a) and one count of Use of Drug Paraphernalia in violation of F.S.S. 893.147 (1).
