The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 3/7/2020, at approximately 2239 hours, Detective Snell of TPD conducted a traffic stop at Fowler Ave and Riverhills Dr, Temple Terrace FL 33617 on a 2012 gray Tacoma Pickup bearing FI tag 834RNW (VIN:5TFMU4FN3CX004717) for a failure to maintain lane. Detective Snell observed the defendant operating the vehicle and detected signs of impairment. Affiant responded to the scene, detected signs of impairment such as bloodshot glassy eyes and a faint smell of an alcoholic beverage on his exhaled breath, and requested the defendant perform field sobriety exercises which the defendant agreed to perform. During the exercises, the defendant showed signs of impairment and was subsequently arrested. The defendant provided a lawful breath sample that resulted in a BAC of .133/.127. The defendant was identified via FL DL.
