<p>On 5/6/21 at approximately 0112 hours, Officers responded to 1203 Town Center Dr., Jupiter, Fl 33458 (Jumby Bay) in reference to an altercation inside the bar that had turned physical. While enroute, Dispatch advised that the suspect was a white male wearing a light blue shirt and jeans. He had struck the bar manager and was currently trying to get back into the business.</p> <p>Upon arrival, contact was made with the bar manager, WF Julianna F Irizarry 10/4/84 who later provided the following sworn statement: At one point tonight, she observed a heated altercation at the pool table inside the business between an older tall male with white hair, light blue shirt, and blue jeans and another male patron. She approached the men to ask them to discontinue the altercation. It was then that the older male, later identified as WM Daniel B Stewart 8/31/62, slapped Irizarry in the chest and additionally tried to strike another bar patron. He was then told to go outside and Irizarry locked the door. She did not sustain and visible injuries and declined medical treatment. She further advised the altercation was caught on security cameras and that the footage could be provided at a later date. She was provided an Evidence.com link for her to submit the video to Jupiter Police Evidence.</p> <p>Contact was also made with eye witness WF Rachel D Byerly 7/5/91 who later provided the following sworn statement: Tonight she was working the bar and at one point she observed an altercation at the pool table that was heated and mostly verbal. She then observed Irizarry approach the men to ask them to stop. At that point, she observed Stewart swing and smack Irizarry in the chest. Even though the bar was loud inside, Stewart smacked Irizarry with enough force for her to hear it from across the room.</p> <p>Stewart was located outside the bar. He appeared intoxicated. His eyes were bloodshot and glassy. He had a strong odor of an unknown alcoholic beverage emanating from his person that became stronger as he spoke. He was also unsteady on his feet. 


Additionally, he was asked to stay seated many times and continued to get up. When asked about the incident he denied getting in any altercation at the business.</p> <p>Based on the above testimony in addition to the actions and behavior of Stewart, probable cause was established to arrest WM Daniel B Stewart because he did actually and intentionally touch or strike *(Julianna F Irizarry) against the will of *(Julianna F Irizarry) contrary to Florida Statute 784.03(1)</p> <p>Additionally, he was intoxicated and endangered the safety of another person or property, or was intoxicated or drank an alcoholic beverage in a public place or in or upon a public conveyance and caused a public disturbance, contrary to Florida Statute 856.011(1).</p> <p>Stewart was placed in handcuffs that were checked for spacing and double locked per policy. While trying to escort him to the police car, he tensed and pulled. While trying to search his person before placing him into the police car he continued to tense, turn, and pull away all while yelling obscenities at officers.</p> <p>Stewart was transported to the Jupiter Police Station for processing and later booked into the Palm Beach County jail for the above charges.</p> <p>The above incident was captured on my BWC. The narrative is a summary of the BWC footage and not purported to be verbatim.</p>
