 On the listed date and time, Deputy Whatley #260039 contacted the driver on a traffic stop for failing to drive on the right side of the roadway after almost getting into a head on collision with a gray, Hyundai Veloster bearing FL tag BQ12I as he was traveling northbound on Falkenburg Rd. It should be noted, the involved vehicle was observed driving southbound in the northbound lanes of Falkenburg Rd for over a half of a mile. Upon contact with the driver, the driver emitted an odor of an alcoholic beverage from his breath, he had slurred speech, had bloodshot and watery eyes, and unstable balance. Field sobriety exercises were conducted and impairment was observed. The driver was arrested for DUI and refused a breath test after Implied Consent warning was read and understood. The driver admitted having consumed four, Michelob Ultra beers prior to the traffic stop tonight. A DAVID query revealed one prior guilty DUI conviction on 06/22/2009. The driver was identified via a valid Florida DL.
