The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:

On the listed date, time, and location the defendant engaged in a heated verbal argument with the victim over her taking the internet router from him. After the victim threw the router into her bedroom the defendant grabbed the victim from behind, wrapping his left forearm and bicep around her neck. The defendant then wrapped his right forearm behind the victim's head and started pushing downward, trying to choke her. After hearing the victim scream for help the witness came into the living room and was able to get the defendant to release his grip. The victim advised that she could still breath when the defendant had her around the neck and did not feel like she was going to loose consciousness at any time. The defendant and victim are mother and son and have always lived together as a family. The victim positively ID'd the defendant as the person who battered her against her will and without her permission. A criminal history was ran on the defendant which met with negative results for previous battery convictions.

The defendant was ID'd via his FL ID card.
